## **Old Business:**

- Insurance update: Insurance policy was renewed for the same number of owners as last year's policy.
  Current policy has outdated information regarding the number of homeowners within the
  Association. Will need to provide correct number of members to insurance carrier. Johanna emailed
  carrier to request one section of the liability policy that covers common areas to be removed.
  Johanna to submit new number of members.
- Spectrum Update: Project was researched, will not pursue.
- Roads: Ask Tony to please not cut so deep next to driveways. Potentially use different material, make the roads more compact, especially at the transition from a paved road onto a Lake Harney Estates road. Test one area (Lake Harney Rd at Winona) first.

#### **New Business:**

- Amending and Restating the Declaration: Board to meet with attorney to begin the process. Proposed
  plan is to exclude Bee Lane, Guy Court, E. Osceola addresses and one property on Maxwell Court that
  accesses his property via Bee Lane. Per attorney's office, properties that are delinquent in
  assessments do not contribute towards the minimum number of owners to vote on the amended
  documents.
- Interest on Reserve accounts: Option provided from BB&T is a variable rate. Scott to research other interest rates and report at next meeting.
- Of 187 properties, 99 are delinquent.
- Ditch on Sutton, several places need dug out. Scott to meet with Todd to discuss. Motion by Emmy to spend up to \$1,000 to clear out the ditch; second by John; motion carried unanimously.
- LHE245 in probate. Monitor account activity.
